90th Meeting Minutes

Started 7th February 2022 19:25 Closed 7th February 2022 19:55

Location: Barking Cat, Ashley Road, Parkstone

1. Welcome and Introduction

Robbie thanked members for coming to the meeting (9 members were present). Minutes of the previous meeting were agreed by Andy and seconded by Annie.

Apologies were received from Paul H - unable to attend due to Covid, Michael (J) – holiday in Austria, Phil – bereavement in family, Graham (J) and Paul G (J) – attending a music gig.

2. Agenda Items

Robbie confirmed that the vote for attending the Cricketers v The Barking Cat for meetings from March onwards was the Cricketers (9) v Barking Cat (6). Andy commented that 9-6 was a good game. Richard confirmed that Penny and Andy Mountford both voted for the Cricketers and Robbie confirmed he did not vote as did not care about either venue. Robbie also confirmed that he understood the reservation of the six who voted to continue with the Barking Cat. Dave mentioned the last meeting was fiasco and we are now just tolerated being here. Annie commented we have to listen to music and the doors are not shut. Dave asked was there any other alternatives to the Cricketers? Robbie said yes, but a charge would apply to others within the same area. Gavin said he liked the Barking Cat as a venue but understood the problems with noise and people playing pool etc. Dave suggested that we had meetings via Zoom and would save on the travelling and parking issues....Paul did not think that this option was a good alternative to a real actual meeting. Andy asked was there an option returning to the Ex-Servicemen's Club? Dave said he would be loathed to go back and if we did return, I think we would be charged. After further discussions it was decided to give the Cricketers a go in March and that Robbie would tell the Barking Cat that we would not have a meeting next month, therefore not requiring their venue for next month rather than saying we no longer need them just in case the Cricketers was equally or
